The Women's Alternative Investment Summit is designed to enhance networking, fundraising, and deal-making opportunities for senior-level women in alternative investments. The Summit opens on the evening of Tuesday, December 1 with a welcome reception at The Setai (Broad Street), followed by a full-day program on Wednesday, December 2, held at the downtown event space Cipriani Wall Street.
